It's that time of year again... **preschool enrollment for Fall 2025.** We currently have a grant funded program for 3 year olds to attend preschool for free. The child must meet at least one of the eligibility requirements on the list. (Please see the cover letter on the enclosed application.) If your family doesn't meet any of the qualifiers listed, we do have other general prek spots available.

This is a great opportunity for your child to attend a pre-k program that focuses on the academic skills that we will build on throughout the next 2 years to prepare for Kindergarten. We encourage you to fill out the attached application and return to the office as soon as possible. Slots are limited and fill up quickly!! Enrollment will be open to the public beginning March 3rd.

Children must be three years of age before August 31, 2025, but cannot have reached their fourth birthday and must meet at least **one of the criteria** listed below and **live within USD 250 school district boundaries.**

- Income qualifies for participation in the federal free or reduced lunch plan
- Custodial parent is single (unmarried) at time of enrollment
- Child in foster care, custodial grandparents/kinship care, or out-of-home placement
- Referral from DCF (Dept. of Children and Families)
- Have a parent that was a teen at the time of the child's birth
- Have a parent lacking a high school diploma or GED
- Developmentally or academically delayed based on assessments
- Child qualifies for migrant status
- Child experiencing homelessness
- Child lacking health insurance
- Preferably potty trained

Due to eligibility requirements, changes to the above information may affect your child's placement in the program. If any changes occur before the 1st day of school, please contact The Center as soon as possible.
